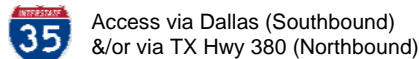
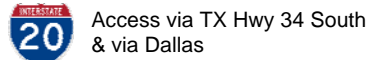
## Greenville, Texas - Strategic Location

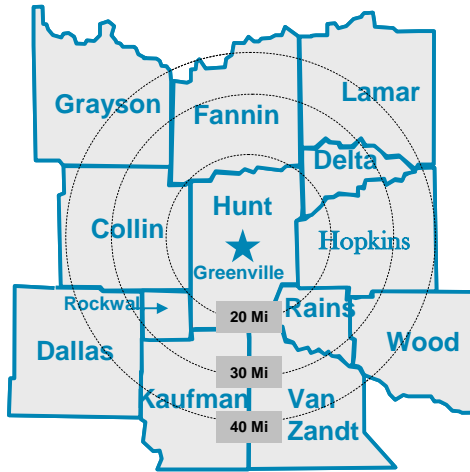

## Incentives

### **Economic Development 4A Sales Tax**

In May 2002, the citizens of Greenville adopted a 1/8 of one percent sales tax to support economic development initiatives. Proceeds are dedicated for the creation and retention of primary jobs and capital investment in Greenville. Depending on the economic impact of the project and specific needs of the company, funds may be used to partially off-set the cost of existing company expansions and new company facility locations. Incentive grants may be applied to purchase land for development and/or buildings, new construction, renovation, infrastructure, equipment, or employee training programs.

### **Low-Cost Land**

The City of Greenville has abundant industrial land available for development, much of it owned by the Greenville EDC. The price per acre is reasonable and negotiable, based on the particular tract of land, the size required by the project, and the total investment & primary jobs created by the project.

### **Tax Abatement**

On a case-by-case basis, the City of Greenville & Hunt County Taxing Entities will consider granting tax abatements on the appraised value of Real Property improvements and Business Personal Property, in accordance with the current guidelines and criteria:

- Must increase the value of the property a minimum of \$1,000,000.00 or more attributable to the increase in value of buildings, structures, site improvements, fixed machinery and equipment, and related fixed improvements
- For new facilities, the value of eligible properties may be abated for up to seven (7) years
- For modernization or expansion, the value of eligible properties may be abated for up to five (5) years.

***NOTE: All Tax Abatements are subject to the creation of a Reinvestment Zone and subsequent approval of the governing bodies of each taxing entity. By State Law, Tax Abatements may NOT be granted by the Greenville Independent School District.***

### **Freeport Exemption – TRIPLE FREEPORT**

The City of Greenville, Greenville ISD, and Hunt Memorial Hospital Taxing Entities offer Freeport Tax Exemption on eligible inventory (Goods detained in Texas for 175 days or less, and used for assembling, storing, manufacturing, repair, maintenance, processing or fabricating purposes).

### **Foreign Trade Zone**

Hunt County, including the City of Greenville, has been designated as a sub-zone of DFW International Airport FTZ #39.

### **Industrial Revenue Bonds**

The Greenville Industrial Development Corporation can issue taxable and tax-exempt bonds to finance land and depreciable property for eligible industrial and manufacturing projects.

### **Tax Increment Financing**

Greenville will consider using Tax Increment Financing to finance needed public improvements in a defined area. The cost of public infrastructure improvements to the area is repaid by the contribution of future tax revenues by each taxing entity.

### **Enterprise Zone Projects (State)**

Within the State of Texas, a project can be nominated as an Enterprise Project either inside an identified zone or +outside of a zone. If qualified by the State, the designated project is eligible to apply for limited state sales and use tax refunds on qualified expenditures for a period of up to five (5) years, with certain requirements for hiring economically disadvantaged or enterprise zone residency. Applications/nominations are selected on a statewide competitive basis.

### **Texas Capital Fund (State)**

The City of Greenville qualifies under the State of Texas Department of Agriculture guidelines for Texas Capital Fund grants and/or loans awarded to help finance the installation of infrastructure for companies that commit to create and/or retain permanent jobs for low and moderate income persons. Applications are selected on a statewide competitive basis.

### **Skills Development Fund (State)**

The Greenville EDC will actively support and work with companies to secure funds through the Texas Workforce Commission Skills Development Fund for customized training programs administered through the Greenville campus of Paris Junior College.

### **Texas Enterprise Fund (State)**

The Texas Enterprise Fund (TEF) is a "deal closing fund" for individual Texas communities in competition with other states for a project location. TEF funds are awarded based on the overall merits of the project, including capital investment, rate of return of public funds, and job creation. Before funds can be awarded, the Governor, Lieutenant Governor and Speaker must unanimously agree to support the use of the TEF for each specific project.



## Available Property

Greenville has abundant low-cost land for build-to-suit opportunities, much of it owned or controlled by the Greenville EDC. The sites are in various stages of planning, currently under development or available for future development. All business and industrial areas offer convenient access to major highway arteries connecting to Interstate 30.

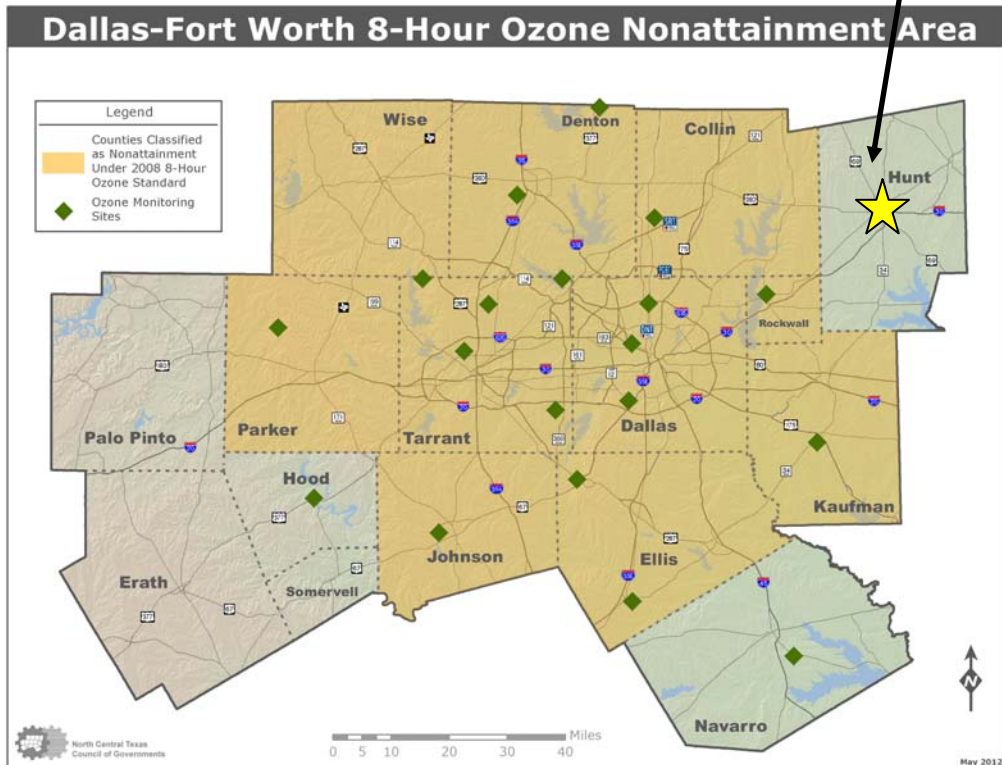

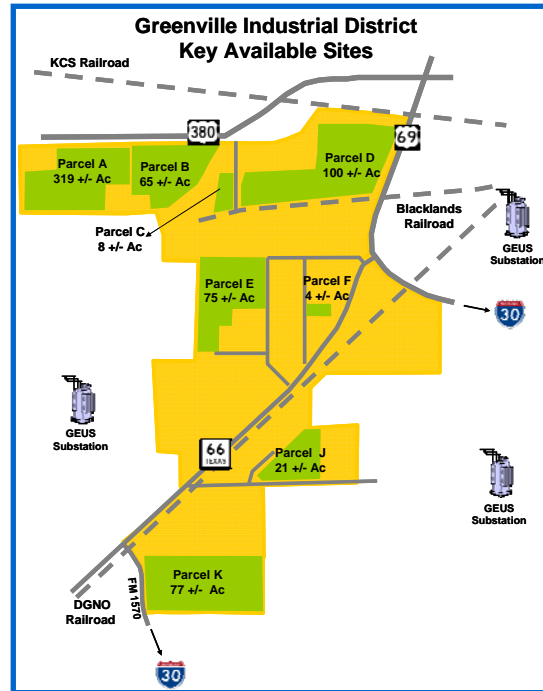




## Greenville Industrial District

## Business Air Park

Air Park is Greenville's business park designed for flex/office/light manufacturing. The park is adjacent to Majors Field Airport, an advantage for companies whose executives and customers who travel by corporate jet, or aviation related facilities.

Existing companies in the park are McKesson, OmniSYS, and Texas Book Company.

There are approximately 100 acres available for development adjacent to existing businesses in the park. The cost and timeline involved in development would be driven by the site location and size.

## Greenville Municipal Airport - Majors Field

The Greenville Municipal Airport, Majors Field (GVT) provides a safe and efficient aviation facility for Greenville and the surrounding region.

Majors Field is the largest airport between Dallas and Little Rock and is located outside the Dallas Terminal Control Area. The primary runway is 150 feet wide, with a length of over 8,000 feet and usable distance of 10,000 feet, enabling it to accommodate some of the largest aircraft in the market.



### Services

Air and ground traffic is directed by FAA certified operators from a 145-foot high control tower equipped to transmit and receive all civilian frequencies. The airport is also features FAA-certified non-Federal airport surveillance radar (ASR), permitting controllers to issue air traffic advisories on all aircraft within a 20-mile radius.

Majors Field Airport boasts many amenities for the general aviation community. The Terminal building serves as the center for general aviation airport operations and management by the fixed base operator (FBO). The Terminal is equipped with weather-tracking computers and provides space for airport administration office functions, fixed base operators, pilot flight planning, restrooms, a pilot lounge, and meeting/conference room.

The terminal area includes more than 30,000 square feet of lighted asphalt ramp space with tiedown stations equipped with static grounds and electrical power outlets to facilitate pre-flight and post-flight operations. The airport, FBO, and tenants on the airfield provide a variety of other services, including:

- Fueling facilities for 100LL and Jet A fuels
- Ground support equipment for aircraft equipped with reciprocating, turboprop, turbojet, and fanjet engines
- Aircraft Maintenance & Aircraft Parts
- Charter Service
- Flight Instruction
- Hanger Space
- Around-the-clock Crash and Fire Protection

Majors Field is home to Greenville's largest employer, L-3 Communications Mission Integration, specializing in the modernization and maintenance of aircraft of all sizes and from all over the world. L-3 Communications has thrived at Majors Field, with the ability to handle all aspects of large aircraft operations, maintenance, and modification on-site.



## Retail

In addition to a wealth of existing retail establishments and restaurants, Greenville has several major existing and planned retail developments. Crossroads Mall, Kari Beth Crossing, Greenville Commons, Greenville Town Center and others offer opportunities for retailers seeking existing space or pad sites in Greenville - a primary Shopping Hub on IH-30 for Hunt County.
